- Before moving into the property we will require rent in advance and a bond as agreed on application, £150.00+VAT lease fee and £250.00+VAT for checking references
- All funds must be cleared before keys are handed over. If transferring to our bank or paying by company cheque please allow five working days for clearance. Preferred method of payment is banker's draft.
